This is a Privacy Notice of **yourtown** Ltd for our fundraising activities.

Our Commitment to Privacy

yourtown is committed to protecting and securing your privacy and the personal information provided to us.

All personal information collected and held by yourtown is protected in accordance with privacy legislation and the Australian Privacy Principles.

What personal information am I being asked to provide?

yourtown collects and holds the following personal information:

- Name and address
- Contact details phone, fax, mobile, email address
- Payment details such as credit card number and expiry
- Date of birth
- Title
- Transaction details associated with the purchase of **yourtown** tickets and donations.

Purpose for Collection

yourtown collects supporters' personal information for the primary purpose of fundraising which includes recording and processing of yourtown ticket sales and donations. It is a legislative requirement that yourtown records purchaser information and contact details for each ticket purchased in the Art Union. These details must be kept for drawing and auditing purposes, in compliance with gaming legislation in the various states and territories where the Art Union operates.

Supporters' personal information is also used for the secondary purpose of marketing, planning, product development and research. For instance, from time to time, promotional offers and special events will be communicated to you through direct marketing and other channels. We may provide this information using any contact number or address provided by post, phone, email and SMS. We will give you the opportunity to opt-out of receiving direct marketing communications through each channel. Your consent to receive direct marketing communications in the above ways will be deemed if you do not opt out when we offer you the opportunity to do so, and will remain current until you advise us otherwise.

Security of Personal Information

yourtown undertakes to take reasonable steps necessary to ensure that supporter information is secure from any unauthorised access or disclosure.

yourtown is compliant with the Payment Card Security Standard (PCI DSS) to ensure that supporter credit card information is secure.

Cookies and Tracking Technology

'Cookies', 'pixel tags' and similar tracking and storage technologies are typically small pieces of data or code that are transferred to an individual's computer to collect information about what the individual is browsing when visiting a web site.

yourtown relies on these technologies for monitoring and analysing our web traffic, and for customising content and browsing experiences based upon an individual's previous visits. In our fundraising website, these technologies help individuals remember specific details (such as their account numbers) and to access various social media features. They also help us to monitor the effectiveness of our promotional campaigns.

We utilise the above technologies through the web tools and third-party services we choose to use (such as Facebook, Google Analytics, Google AdWords and Sizmek). These services use these same technologies to determine the advertisements you see when using these services.

Individuals have choice whether they wish to allow the collection and use of this information for these purposes. For instance, we require individuals to opt-in by providing reminder messages with consent buttons. These are presented when first entering a site and/or visiting a specific web page. Individuals can also modify their computer settings to stop receiving cookies.
