Every day, we work with children and young people to find jobs, learn skills, become great parents and live safe happy lives. The demand for our services continues to grow each year. In 2016 alone, children, young people and families made almost 200,000 contacts with **yourtown** and close to 40,000 people accessed our face-to-face services.

How we help:

- **Kids Helpline** is Australia's only free, private and confidential 24/7 phone and online counselling service for young people aged 5 to 25. Our counsellors respond to more than 3,400 contacts every week from children and young people seeking information, support or counselling.
- **Counselling and Support** via Kids Helpline, Parentline for parents and carers, face-to-face support and Kids Helpline @ School.

- **Family and Community services** help young families learn positive parenting and strengthen connections with the community.
- Education and Engagement services support young people to remain in school and offer other positive pathways.
- Job Training and Employment services give young people extra life choices and get them jobs.
- Services specifically for **Aboriginal and Torres Strait Islander Peoples** create job options and education opportunities.
- Accommodation services support families facing homelessness and/or family and domestic violence.

What is Workplace Giving?

Through Workplace Giving programs, employees nominate their preferred charity and specify the amount from their pre-tax pay they wish to donate each pay period. The employer then pays the donation to the charity.

As donations are deducted from pre-tax pay, the tax benefit for you is immediate - there is no need to keep receipts or claim at tax time.

How to get involved

Ask your payroll or HR department if they offer Workplace Giving. If so, all you need to do is nominate yourtown as your chosen charity.
